3. A standard NBA game consists of 48 minutes of regular time. As this challenge is based on win/loss predictions, if a game ends in a tie at the end of regular time, the final result will be determined by the outcome of overtime.
4. NBA playoff games follow a best-of-seven format. Game 5, 6, and 7 of the Finals will only take place if necessary. If a team wins all four of the first four games, the Finals will conclude after Game 4, and this Event will also end on the same day. The final schedule is subject to NBA's official announcements.
5. There are no restrictions on the number of guesses placed for each game in

this challenge.

6. Participants cannot cancel or modify their guesses after placing them.

7. Guess placement for each game will be closed once the match begins. After the game starts, Participants will no longer be able to place, modify, or cancel their guesses.

8. Participating in this challenge may result in the loss of initial Reward Points.

9. If a guess is correct, the participant will receive Reward Points based on the odds at the time of placing the guess.

10. As the guessing odds are provided by third parties, WeTrade does not participate in the calculation of the odds nor hold any opinion on them. The odds are determined by global industry experts based on various factors and are subject to constant fluctuation.

11. WeTrade is not responsible for any delayed guesses due to network or device issues.

12. The actual guessing odds applied will be the real-time odds at the moment the guess is successfully placed.
